However, it may contain crystalline silica (quartz), a substance which has been listed as a carcinogen by ACGIH, NTP and IARC. Crystalline silica is a naturally- occurring mineral component of many sands and clays. Although the carcinogenic potential of crystalline silica in humans is controversial, it must be considered if it is inhaled under excessive exposure conditions. The respirable portion of the silica that may be contained in this product, however, is small, such that inhalation exposure during anticipated conditions of use is minimal.
